By-laws need to be updated to be submitted to World Service as part of the change in regions. Cathy G moved to accept the recommendations below, and Judy M. seconded. Motion approved. Recommendations:

- Remove reference to a region number in the by-laws
- Update by-laws to require that both the Convention and Retreat chairs meet the same abstinence requirements (1 year). This has been done in practice but is not in the by-laws.
- 7. World Service
  - Cathy G will be attending WSBC along with Amy D. WSO asked us to consider consent agenda items and motions. Each intergroup must vote on each item. Not voting on the item itself, but voting to include the agenda item as part of the WSBC debate/discussion. It is a topic that benefits OA as a whole.
  - Cathy reviewed the WSO agenda questionnaire and will submit the intergroup votes on behalf of Unity IG.
- 8. Events/Committee reports:
  - Buffalo Retreat- Jean K shared that information about the Buffalo
    retreat will be in the newsletter and sent by email to those that have
    attended before. Registration will open soon. Scholarships are available.
    Cost is higher than it has been. Share with groups that scholarships are
