- 3. Review October Minutes Cathy G. moved to accept October minutes as amended; second by Sarah. October minutes approved.
- 4. October Treasurer's Report:
  - Convention receipts, expenses and literature sales. Did not get final invoice from hotel until November so expenses will be greater next month.
  - Dru F. moved to accept the report; second by Cathy G. October Treasurer's report approved.

  - Typically groups match the topic with the step or tradition for the month, but Vicky will take articles on anything. Anyone can submit at anytime. We ask groups to sign up so there are cheerleaders encouraging articles. It is a good way to get credit for using the writing tool.
- 6. Intergroup Business:
  - Elected positions Still have openings for three Region 5 reps, and two more World Service delegates. Take it back to your groups to encourage people to sign up
  - WSO conference will be virtual this year in May (alternating with in-person meetings every other year). It is a business meeting. You get to see how things get done. You meet people from all over the world. All delegates are asked to join one of the committees. You meet with subcommittees and as a big group

to vote on amendments. In February, you get sent a list of amendments to consider for discussion at WSO. Need 1 year of abstinence and to have served above the group level for at least 3 months.

- Additional coordinator service positions available:

Unfortunately, there were 190 people registered with 9 scholarships but only 130 attended (at December meeting, the number of attendees was corrected to 160 of the 190 registered). Don't know why there wasn't the enthusiasm that there was last year. It is remarkable to experience the fellowship and in-person connections.
  - It appears we will be breaking even financially or having a slight income.
  - The program was excellent. They encouraged participation and mingling.
  - Had a little issue with technology for credit card payments for literature.
    The tablet would not maintain a charge, so sporadic Wifi and we don't
    know if all charges actually went through. Will send an email to
    participants to ask people to check if charges went through.
