- 3. Review December Minutes -
 - Cathy G. moved to accept December minutes; second by Betty. Minutes approved.
- 4. December Treasurer's Report:
 - Income and expense. Income from 7th step donations. Constant contact is an annual fee that gets paid in December. Slight loss on the month because of large annual expense, but total for the year income is above expenses. Operating account balance is \$36,901 and prudent reserve account is always at \$15,000. 7th step donations were especially light in December, below our typical monthly expenses.
 - Prudent reserve never gets touched. It is for emergency fund if there is a big unexpected expense. Operating account is to fund things that we are doing (downpayment for retreat or convention, etc.). If we hold too much money in operating account, it gets sent to Region and WSO. UIG is in good financial position. We have lots of ideas of things we want to do. We need people to step up and make it happen. We have the financial resources to support lots of things to help carry the message. We need people to do those activities.
 - WSO trustees send out a notification of a change of recommendations for groups making 7th step donations above the group level. For a long time, recommendation has been for 60% to intergroup, 30% to WSO and 10% to Region. They have changed the recommendation to 50% to intergroup, 40% to WSO, 10% to Region. Letter from Trustees stated that costs are going up for storage of materials, paying people to send out materials, translating literature to make it more available, and meeting more requests for WSO to provide support and services. More details are in the January newsletter. Please take the information back to your meetings.
 - Sarah S. moved to accept the report; second by Rita L. Treasurer's report approved.
