- 4. February Treasurer's Report:
 - Income includes registrations for Buffalo retreat, literature sales (largely at Convention), donations from groups. Income is ahead of expenses so far because registrations are coming in and we have not paid anything for the retreat yet. Operating account balance is \$57,215.35. Prudent reserve is \$15,000.
 - Cathy G. moved to accept the report; second by Rita L.. February Treasurer's report approved.

- 6. Intergroup Business:
 - Constant Contact update Marque, Jean and 2 others recently got trained to send out Constant Contact emails (in addition to Howard). The 4 who just got trained plan to send out emails. Howard will do the database maintenance.
 They did some testing. If you go to the UIG website (overeaters.org) and fill

out the request to get newsletters and emails and event notifications, you are automatically added to Constant Contact. If reps put their email address in the UIG meeting chat, Jean will be able to send out UIG documents to the group of reps who have attended at least one meeting.

 - Convention chairs if no one steps forward very soon, we will not have a convention in 2025.
 - Recommend that we let go of convention for this year. Anyone considering the position can look towards 2026.
 - Suggestion to consider making it a 1-day Zoom event. Even if we
 make it a Zoom event, would need to have chairs and work out
 logistics. May want to consider in the future.
 - Take it back to groups to see if anyone is willing to put energy into a convention-type event whether in person or virtual.
 - Abstinence requirement for convention chair is 1-year abstinence. For Zoom and other service positions, we ask for 90 days abstinence.
 - Motion from Betty C. to cancel any consideration of holding a convention in 2025. Second by Cathy G.. Motion passed.

7. Events/Committee reports:

- Unity Intergroup Retreat in Buffalo April 4-6, 2025. Registration deadline is March 10th. We have to guarantee 70 participants. Doing a big push to get people registered. Don't want to cancel for low registration if some are waiting to register. If anyone is considering going, they should register ASAP. There are still scholarships available. Make sure people in your meetings know there are scholarships available.
 - If we are within 2 people of the minimum, the board may decide to cover that. But we would rather have people there enhancing recovery.
