4. June and July Treasurer's Report
 - Unity Intergroup YTD has received \$54,310 and has paid \$64,457 in expenses. This results in a Cash Basis loss of \$10,147
 - Unity Intergroup has provided \$5,000 to Region 5 and \$10,000 to World Service, using prior year(s) receipts.
 - Unity Intergroup is budgeted to lose \$16,490 this fiscal year; however, we remain in a strong financial position. This is evidenced that we have \$46,434.13 total assets.
 - Tax returns are complete and will be mailed soon.
 - July is a new fiscal year. Income of \$2408.12 with \$1663.77 in expenses making a YTD surplus of \$744.35 with a balance of \$47,178.00 in the bank with no anticipated expenses in the future.
 - Our next large expense will be the Spring Retreat.
